

## SACRAMENTO COMMONS ESSENTIAL HOUSING FOR THE DOWNTOWN DISTRICT

Situated at the intersection of Fifth & O Streets in Downtown Sacramento, the Sacramento Commons development will consist of two mirrored, seven-story buildings. When complete, the development will include 412 Studio-2 bedroom apartments, 24 live-work units, various amenity spaces, retail and underground parking totaling 647,420 sf.

Developed by Weidner Apartment Homes and led by Deacon Construction, Van Tilburg, Banvard & Soderbergh Architecture, and Kitchell CEM, the project is scheduled for completion August of 2022.



# ASK AN ARCHITECT

#### What makes a good neighborhood or community – and how does that model shift between urban, suburban and exurban densities?

To start, a good neighborhood provides the public and private space that its residents need. A city dweller may accept a small apartment so long as nearby cafés, bars, clubs and parks can be their "living room". Conversely, many families want a singlefamily house in the suburbs to have space to grow and a backyard for their children to explore.

But a good neighborhood must do more. Neighborhoods aren't isolated they're part of a longer community and should reflect its values. Today, Sacramento's aspirational values are social equity and environmental sustainability — so good neighborhoods should aim to become more inclusive and walkable.

I've always felt that our success at the Capitol Area Development Authority was because most of us were involved in the daily care of the apartments and businesses we managed. The insights of our property management and maintenance staff helped our development staff take on projects that contributed to the neighborhood's evolution. When I retired, I was grateful to have helped build an authentic neighborhood – with an eclectic mix of buildings built over time that are all good neighbors, that are all cared for.

#### How can design be used to create educational environments that are safer and healthier for students of all ages?

The COVID-19 pandemic has forced us to further appreciate the role of schools as an essential part of the communities in which we live and work. When families and neighbors embrace their local schools, they become part of the system that also keeps them safe. Passive safety strategies, such as single main entry points and easily supervised spaces are an excellent start, but school safety begins with students' social and emotional needs being met — how are we making children feel when they enter their school?

While teachers are at the forefront of the student experience, architects who design schools can also play an important role by creating welcoming spaces that accommodate a diverse group of learners. Healthy school initiatives, (such as) indoor environmental quality (natural and mechanical ventilation, for example) are proving essential to controlling the spread of the disease. Simple sustainable design strategies such as natural daylighting and view windows have been proven to increase test scores as well as student attentiveness. The choices we make for building materials also make a difference, providing a welcoming aesthetic, but also allowing ease of cleaning and maintenance of school buildings.

## How do you weave human dignity and resilience throughout your design process?

Working with nonprofits we are often told: "We only need the bare minimum." For organizations with finite resources, design feels like a luxury.

Part of our job as architects is to help show that good design can not only be affordable and add value — reducing the burden on these service provider, instead of having to overcome spatial challenges — we can help catalyze and (amplify) their mission.

When we invest in well-designed, high performing spaces we are investing in the dignity of the people who will use them. This is reciprocated by the care and respect and appreciation by those users who sustain these places. A space that is loved will endure, and that is the surest form of sustainability.

### What makes architectural photography so powerful?

The power of architectural photography is in the eyes of the photographer — by immersing themselves into the story of the building, capturing the essence of the design and perhaps the history of the city the building is located in.

Through the lens of the photographer, one can experience new angles of the monument that might have been captured many times but has not been seen in that one particular way.

The main goal is to transfer the sense of architecture through that one image, whether that's the texture of the materials, patterns of the surfaces, or how light moves through the building. It is as if there is a mystery to be revealed and only the photographer has that magical power.

### How will the built environment be different after COVID-19?

We will still have retail, offices, restaurants, event venues and high density housing and urban cores. We will still have parks and concerts. What will likely change is providing for flexibility. Restaurants were ill prepared (to lose) indoor dining, the office market is ill prepared for the coming remote work alternative and event locations have been shut down for six months due to the pandemic.

I see flexibility as the key word for future development. Flexibility of use, indoor/outdoor flexibility and planning for a bit more distance as people gather in fixed locations. I think (the) key to this is that most people will not want to actually change their social habits. Work environment changes may be more significant as remote working has proven successful beyond expectations.

There is however still a strong social aspect about a fixed workplace where people can meet, talk and be connected. Considering that, enclosed open work spaces will have a new and perhaps longterm emphasis on air cleaning systems, protections between work desks, screening in public areas and more disposability at break stations.

## What are specific ways architects and good design can promote equity in healthcare?

The architect's role in society as the designer of the built environment puts us on the forefront of the struggle to provide equity for all, regardless of physical ability, race, gender, ethnicity or sexual orientation. In healthcare, we must consider how our design affects all patients' safety, length of stay, readmission rate, experience and well-being. Equally important is its effect on the care team's satisfaction and performance.

The devastating impact of COVID-19 on people of color serves as a stark reminder that some groups in our society face different health challenges (e.g., higher occurrences of chronic disease, diabetes and cardiovascular problems) and may not have the same access to affordable, quality care as others do.


Members of the LGBT community and patients with disabilities also encounter unique obstacles to equitable care in hospitals, clinics and other facilities. The growing trend of smaller, community-based clinics allows designers to incorporate features and nuances that consider and complement the demographics of the neighborhood they serve. Achieving the goal of patient-centered care requires recognizing and accepting that this phrase means something different to everyone.
