

1. WAIVER AND RELEASE. **Tour Start Location:** Paseo between the two buildings.


Parking: There is a public parking lot on the east end of Main Street.

Main Street Plaza is a mixed use, affordable multifamily project located on an active corner in Roseville's Old Town neighborhood, just northwest of downtown. Aimed at revitalizing the Old Town and downtown areas of Roseville, the community fills a vacant lot formerly occupied by the Roseville Hotel, and provides much needed housing and new retail opportunities to the area.

Two four-story buildings include 65 residences, offices, and 3,000 square feet of retail space. The one, two, and three bedroom apartments continue to address the City of Roseville's plan to increase affordable housing for the local workforce, and also includes units for veterans and special needs populations.

Studio W Architects transformed and rejuvenated an existing commercial property at 1930 H Street in midtown Sacramento into the new home of the firm's Sacramento Studio.

The single-story, 8,000 square foot building is located adjacent to the new AIA California office, providing a strong design synergy for the two practices. The renovated space boasts a contemporary workplace environment with a lobby/reception area off the H Street entrance, an open workstation area, private offices, conference/meeting rooms, a staff kitchen/lounge and a workroom with a library and showroom for materials and products. Exterior improvements included façade, lighting, landscaping and parking upgrades.

Celebrating its 78th year, AIA California (AIA CA) advocates on behalf of the architectural profession for its 11,000 members statewide. In need of a more prominent and outward-facing local presence, AIA CA moved their offices to a midtown Sacramento building originally built in the 1930s. The existing brick building has tremendous character, concrete floors and exposed wood trusses.

Re-vitalization of the historic structure focuses on two important areas; rehabilitation and replacement of existing finishes and systems to create a more sustainable environment, and creation of a space that provides a healthy workplace for staff while serving the needs of membership. With no two staff positions the same, we created an individualized approach to working environments while adding flexible communal and meeting spaces for membership and the community at large.

A design-build project with DPR and HKS, Inc. that includes a new, ground-up student housing complex with a maximum capacity of 809 beds. The project consists of of three buildings that are connected by social balconies.

The resulting complex includes common rooms, residence assistant apartments, lounges, recreation rooms, an advising center, community space, a community kitchen, music room, maintenance shops and laundry facilities.

The project is targeting LEED Gold.
